 - a. New agent: Egan Gost Non- Profit Alliance
 - Add 2 new waivers cover property damage to golf cart & add ins. Coverage to driver who is towing
 - waivers: implementing 2 waivers that every volunteer needs to sign
 - c. Total for extra policies from \$1250 to \$1962
 - 2 new policies added: 1. property coverage golf cart (damage & loss)=\$385/year, 2. Nonowned Hired Auto Insurance policy (coverage for driver when towing trailer)=\$249/year
